Explain: One potential non-jurisdictional depressional feature was identified in the request for jurisdictional determination report submitted by BDY Environmental, LLC., for the property located to the south of Hoggett Ford Road in Hermitage, Davidson County, Tennessee (N 36.17014 and Longitude -86.622428). The review area contains an isolated 0.308 acre depressional wetland that appears to have been a farm pond, as evidenced by 1997-2003 aerial photography depicting the

feature as a depression with open water surrounded by pasture. The feature is mapped by the US Fish and Wildlife Service National Wetlands Inventory as a palustrine, unconsolidated-bottom, permanently flooded wetland (PUBH).

The USGS 7.5 minute Hermitage Topographic Quadrangle maps the wetland as a closed depressional feature with no topographic surface inlet or outlet channels. Field observations confirm that the wetland has no inlet or outlet channels and that the feature was previously bermed and excavated. The nearest defined channel, an unnamed tributary to Stoners Creek, is located approximately 770 feet to the north. The wetland is isolated from this watercourse by the Hoggett Ford Road embankment and a shallow, pastured valley containing no defined channel. Stoners Creek is the nearest traditionally navigable water within the wetland's HUC 12, and is located approximately 3,600 feet north of the wetland along projected surface flow pathways. The Stones River is located within a separate HUC 12 watershed, approximately 2,900 feet to the southwest along projected surface flow pathways.

The wetland is characterized by a shallow central pool (inundated to a maximum depth of 15 inches during the June 10, 2015 delineation) with well-established wetland vegetation and hydric soils. The interior of the wetland is vegetated by herbaceous hydrophytic plants including *Carex frankii*, *Polygonum punctatum*, and *Leersia oryzoides*. *Salix nigra*, *Populus deltoides*, and *Celtis laevigata* form a tree/sapling canopy over the outer portions of the wetland surrounding the pool.

Soils within Wetland 1 are strongly depleted silt loam with a matrix color of IOYR 5/2, and possess iron-manganese masses. The soils are mapped by the NRCS as Stiversville Loam 3-12% slopes (Appendix 5), which is classed in Hydrologic Soil Group A. Group A soils are deep, well drained, and have a high infiltration rate (NRCS Web Soil Survey, 2015).

Wetland hydrology indicators include the depressional geomorphic position, oxidized rhizospheres, soil saturation, aquatic fauna (Physa), and surface water (Appendix 2). The pool within the wetland was dry during a previous site visit in May 2015, and the wetland's hydroperiod appears to be flashy with direct response to recent rainfall and relatively rapid subsurface drainage/evapotranspiration.

The feature listed above was examined, including a review of past jurisdictional determinations, maps/plans submitted by the applicant, USGS Survey Maps, aerial photographs and observations recorded during the site inspection. The data does not indicate a surface connection or shallow groundwater connection to waters of the U.S. A site visit on 22 OCT 2015 confirmed that Wetland-1 does not have a surface or shallow groundwater connection to waters of the U.S. and is geographically isolated. Wetland-1 does not support a link to interstate or foreign commerce. Wetland-1 is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes in interstate commerce. Wetland-1 was determined to be non-jurisdictional under the CWA because it is isolated and lacks a link to interstate commerce sufficient to serve as a basis for jurisdiction.

C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
