C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The review area for this approved JD only includes the features demarcated with a black line and labeled as "WC-3", "WC-4", and "WC-7" on the attached map entitled "LRN-2015-00707 Sheet 1". These features were determined to be non-jurisdictional based on the absence of an Ordinary High Water Mark and the absence of wetland indicators required for wetland determination. The review area is confined to the property boundaries highlighted in yellow on the attached map entitled "LRN-2015-00707 Sheet 1" dated 11/20/2015 was submitted by BDY Natural Sciences Consultants (BDY), Inc, for the area identified as the Scales Property, Clovercroft Road, Williamson County, Tennessee.

The featured identified as "WC-3" is located on the northwest portion of the site and measures approximately 276-linear feet in length. The feature begins at N35.94172, W-86.7028 and terminates at N35.94114, W-86.70222. "WC-3" does not meet the definition of a jurisdictional wetland, nor does the feature exhibit an ordinary high water mark (OHWM). This feature labeled "WC-3" does not appear on USGS Topographic Maps, USGS NHD Maps, USDA Williamson County Soil Survey Maps or the National Wetlands Inventory (NWI) maps as an aquatic feature. The feature identified as "WC-3" is an upland erosional feature and not WOUS.

The feature identified as "WC-4" is located on the southern property boundary adjacent to Clovercroft Road. The feature measures approximately 271-linear feet in length. The feature originates at N 35.937405 W-86.698691 near Wetland-2 and terminates at N 35.937195 W-86.699228 at a culvert passing under Clovercroft Road. While WC-4 transmits surface water from Wetland-2 offsite through overland flow, the feature does not receive overland flow with the frequency and magnitude to

establish an OHWM. "WC-4" does not meet the definition of a jurisdictional wetland, nor does the feature exhibit an ordinary high water mark (OHWM). This feature labeled "WC-4" does not appear on USGS Topographic Maps, USGS NHD Maps, USDA Williamson County Soil Survey Maps or the National Wetlands Inventory (NWI) maps as an aquatic feature. The feature identified as "WC-4" is an upland drainage feature and not WOUS.

The feature identified as "WC-7" is located on the eastern property boundary originating at N 35.939490, W-86.693435 near Wetland-4 and terminates at N 35.939911, W-86.694294 near WC-8(Ephemeral Stream). While WC-7 transmits surface water from Wetland-4 through overland flow, the feature does not receive overland flow with the frequency and magnitude to establish an OHWM. The feature measures approximately 360-linear feet in length. "WC-7" does not meet the definition of a jurisdictional wetland, nor does the feature exhibit an ordinary high water mark (OHWM). This feature labeled "WC-7" does not appear on USGS Topographic Maps, USGS NHD Maps, USDA Williamson County Soil Survey Maps or the National Wetlands Inventory (NWI) maps as an aquatic feature. The feature identified as "WC-4" is an upland drainage feature and not WOUS.

Based on a review of information submitted by BDY Inc., on 29-JUN-2015, including: aerial photography dated 02-SEP-2015, USGS Nolensville, TN Quadrangle Map, NRCS Soil Maps for Williamson County, Tennessee, a review of the USGS National Hydrologic Dataset (NHD) Map, U.S. Fish and Wildlife National Wetland Inventory (NWI) database, photographs of the project site, and a site inspection of the survey area on 28-AUG-2015, the features identified as "WC-3" "WC-4", and "WC-7" are not a water of the U.S. and are not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

The aquatic features identified as "Stream-1", "Stream-1A", "Stream-1B", "Stream-2", "WC-1", "WC-2A", "WC-2B", "WC-2C", "WC-5", "WC-6", "WC-8", "Wetland-1", "Wetland-2", "Wetland-3", "Wetland-4" and "Wetland-5" on the attached map entitled "LRN-2015-00707 Sheet 1" dated 11/20/2015 may be waters of the United States; thus, these sixteen features are being evaluated under a Preliminary Jurisdictional Determination.
