- C. Additional comments to support AJD:** This AJD was completed in relation to a request received by the Corps Planning Division concerning an area located behind the houses on Village Way, Brentwood, TN. The slope to the south has created a disturbed area around the stream. Multiple seeps were observed throughout the area.
