Explain: **An open water, pond feature identified as PND-1 encompasses approximately 0.1 acres was field verified on 11/23/2021 as an isolated feature that was a man-made feature by excavating in uplands and side-casting the material. There are no inlet or outlet drainage features to the pond and it was not constructed within a tributary nor wetland. It does not drain directly or indirectly to any waters of the U.S. and does not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; does**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Isolated feature, 0.10-acre in size, is a man-made, depressional pond excavated in uplands with no inlet or outlet drainage features. It appears to have been utilized for agricultural purposes in the past.
