Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Two grassy swale features were identified as "Grassy Swale-1" and "Grassy Swale-2" in the request for jurisdictional determination report submitted by BDY Environmental, LLC, for the area identified as the Ingram Property located at 5525 Leipers Creek Road, Franklin, Williamson County, Tennessee.

The featured identified as "Grassy Swale-1" is approximately 227-linear feet in length. This feature does not appear on USGS Topographic Maps, USGS NHD Maps, USDA Williamson County Soil Survey Maps or the National Wetlands Inventory (NWI) maps. The feature begins at latitude 35.853218 and longitude -87.03793 and transverses down gradient to latitude 35.85274 and longitude -87.037459, where ordinary high water mark indicators exist below a head-cut, where Ephemeral Stream-3 originates. A custom soil resource report generated for the site indicates Grassy Swale-1 is located within dry land soils composed of the following soil series: Dellrose gravelly silt loam, 12 to 20 percent slopes, eroded (DeD); Humphreys gravelly silt loam, 5 to 12 percent slopes (HpC); and Humphreys gravelly silt loam, 2 to 5 percent slopes (HpB). None of these soil series are considered hydric soils, nor were any wetlands discovered during the site visit. A review of the project site on the Tennessee Streamstats website, http://streamstatsags.cr.usgs.gov/v3\_beta/viewer.htm?stabbr=TN does not list Grassy Swale-1 as a potential stream and indicates the feature is located at the top of the watershed. Grassy Swale-1 does not meet the definition of wetland and does not have lateral limits of jurisdiction (OHWM); therefore, Grassy Swale-1 is not a water of the U.S. and is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

The featured identified as "Grassy Swale-2" is approximately 183-linear feet in length. This feature does not appear on USGS Topographic Maps, USGS NHD Maps, USDA Williamson County Soil Survey Maps or the National Wetlands Inventory (NWI) maps. Grassy Swale-2 forms directly below an alluvial fan formed by the termination of ordinary high water mark indicators of aquatic feature identified as Ephemeral Stream-4. Grassy Swale-2 originates at latitude 35.852738 and longitude -87.036378 transverses down gradient to latitude 35.852849 and longitude -87.035779, where the feature leaves the review area through a culvert under Leipers Creek Road. Grassy Swale-2 does not exhibit OHWM indicators. The feature does exhibit evidence of overland sheet flow with faint a drainage patterns within the otherwise grassy depressional area. Grassy Swale-2 is located on Humphreys gravelly silt loam, 5 to 12 percent slopes (HpC). The HpC series is classified as well drained soils with no frequency to pond or flood. HpC soils are classified as dry land soils (Not Hydric), and no wetlands were identified during the 08 JAN 2020 site visit. A review of the project site on the Tennessee Streamstats website, http://streamstatsags.cr.usgs.gov/v3 beta/viewer.htm?stabbr=TN does not list Grassy Swale-2 as a potential stream and indicates the feature is located at the top of the watershed. Grassy Swale -2 does not meet the definition of does not meet the definition of wetland and does not have lateral limits of jurisdiction (OHWM); therefore, Grassy Swale-2 is not a water of the U.S. and is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

Based on a review of information submitted by BDY Environmental, LLC, on 13-FEB-2020, including: USGS 7.5 minute Theta Topo Quad; TDOT Aerial Map dated 13-FEB-2020, NRCS Soil Maps for Williamson County, Tennessee, a review of the USGS National Hydrologic Dataset (NHD) Map, U.S. Fish and Wildlife National Wetland Inventory (NWI) database, photographs of the project site, and a site inspection of the survey area on 08-JAN-2020, the features identified as "Grassy Swale-1" and "Grassy Swale-2" are not waters of the U.S. and are not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. If the aquatic resource is a wetland directly abutting a tributary with perennial flow, skip to Section III.D.4.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. The determination whether a significant nexus exists is determined in Section III.C below.

#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
