S-1 (85 linear feet) is a non-tributary that ends in a series of sinkholes, disturbed by the construction of Freehill Road and a stormwater drainage system S-1 not considered a tributary as it does not have a direct or indirect connection to a TNW. This feature flows into a series of sinkholes on site. The site

was verified to have many sinkholes throughout the review area. Using LiDAR/DEM mapping and aerial imagery it was determined that this feature does not reach a TNW. The resource does not support a link to interstate or foreign commerce, because it is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and soil in interstate or foreign commerce and is not known to be used for industrial purposes in interstate commerce. S-1 is not considered WOTUS because it is not a tributary.

The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page 41217), states "For clarification, it should be noted that we generally do not consider the following waters to be Waters of the United States.... (a) non-tidal drainage and irrigation ditches excavated on dry land." And (e) Waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and the resulting body of water meets the definition of Waters of the U.S."

S-4 (205 linear feet) is an upland drainage feature, which was formed in associated with the road construction/expansion of W Main St.

WA (0.064 acre) S-5 (190 linear feet) and WB (0.024 acre) were formed in uplands as a consequence to the placement of fill in an upland drainage area. WB was formed on the north side of a driveway installed prior to 1950 and abandoned between 1957 and 1980. WA was formed from the deposit of fill/large rocks was placed in the area. S-5 formed incidentally and can be seen on LiDAR to direct sheet flow around the placed rock/fill.

Based on a review of information submitted by TTL, Inc and aerial photography, LiDAR/DEM maps, a USGS quadrangle map, NRCS Soil Maps, soil samples, a review of the National Hydrologic Dataset, U.S. Fish and Wildlife National Wetland Inventory database, wetland data sheets from Eastern Mountain and Piedmont Regional Supplement to the 1987 Wetland Delineation Manual (Version 2.0), photographs of the project site, and a site inspection of the survey area on July 19, 2022. I have determined that S-1, WA, S-5, WB, and S-4 are not waters of the U.S. and are not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a)

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
