C. Additional comments to support AJD: The FEMA floodplain map provided in ORM2 indicates the AJD review area is not within a FEMA-mapped floodplain. It is possible that W-1 drains to an upland ditch located outside the AJD review area during very wet periods of the year. The upland ditch may carry water from W-1 to the Bakers Creek embayment of Wheeler Lake located approximately 2,000 linear feet from W-1. The upland ditch is not indicated as a stream on the USGS topographic quadrangle map or on the NWI map.
