Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **One wetland (W001) exists within the AJD review area. W001 is a 0.22 acre depressionnal wetland completely encircled by an elevated road. (Lat. 34.88816, Long. -85.74845). W001 has no hydrological connection to other waters. W001 is the result of poor drainage conditions created by the construction of an elevated**

road, constructed between 1974 and 1983. W001 is located within the NRCS-mapped non-hydric soil series, Etowah silt loam.

Based on a review of information submitted by the Tennessee Valley Authority, including: a USGS quadrangle map, NRCS Soil Maps for Morgan County, Alabama, a review of the National Hydrologic Dataset, U.S. Fish and Wildlife National Wetland Inventory database, and photographs of the review area; the Corps has determined W001 is not part of a tributary system to interstate or navigable waters of the United States and is not adjacent to such tributary waters.

The wetland does not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. The wetland is determined to not be jurisdictional under the CWA because the wetland lacks links to interstate commerce sufficient to serve as a basis for jurisdiction. In consideration of the January 2, 2001, United States Supreme Court decision, *Solid Waste Agency of Northern Cook County v. United States Army Corps of Engineers*, we have determined that W001 is isolated and not jurisdictional under Section 404 of the CWA.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
