R-23A: A 433 linear-foot (0.03 acre) non-jurisdictional upland drainage feature, R-23A, is located within the review area. The Corps has determined that this feature is not a tributary because it does not exhibit a surface connection or shallow groundwater connection to waters of the U.S. Much of the area surrounding R-23A has been previously disturbed by pre-SMCRA and pre-Clean Water Act mining activities, estimated over 50-years ago. R-23A originates on a forested mountainside, where it exhibits an Ordinary High Water Mark (OHWM), then

continues downhill to a previously disturbed, relatively flat, mining bench and road. The substrate of R-23A is comprised of rock, silt, and clay. The OHWM of R-23A disappears on the mining bench and road; all surface flow goes subsurface at this location. It was determined via on-the-ground site visits that the closest downgradient, potentially-jurisdictional tributary is R-23B, an unnamed ephemeral tributary of Catron Creek. As requested by the landowner's consultant, the jurisdictional status of R-23B is not addressed by this approved-JD; the jurisdictional status of R-23B is addressed in a future preliminary-JD. Utilizing aerial mapping and on-the-ground site visits, it was determined that the headwater of R-23B is located approximately 620 feet down gradient from the downstream OHWM extents of R-23A. There is no evidence of surface flow, shallow subsurface flow, or OHWM within this stretch of 620 linear feet. R-23A and R-23B are depicted on attachments to this document.

It has been determined that R-23A is not a tributary and does not exhibit a surface connection or shallow groundwater connection to waters of the U.S. R-23A is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. The feature is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a) because it lacks a link to interstate or foreign commerce sufficient to serve as a basis for jurisdiction. In conclusion, there are no aquatic resources within the survey area that meet the definitions of waters of the U.S. as listed in 33 CFR Part 328.3(a).

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
