Explain: Features identified in the request for jurisdictional determination by CEC, Inc are as follows:

Wetland (WTL-1) is approximately 0.23 acres in size and appears to have been an abandoned farm pond that has developed wetland characteristics. During a site visit on 21 November 2016, the wetland site did not contain any surface water. It appears to receive hydrology via overland stormwater flow. It is a low functioning isolated wetland

that does not contain any inlet or outlet areas nor evidence that the feature was constructed in a water of the U.S. Thus, the feature is geographically isolated with no hydrologic connection to any other waters of the U.S. Additionally, the site is not mapped on the National Wetlands Inventory Map and does not flow directly or indirectly into a TNW or connected to interstate or foreign commerce. This feature is not used by interstate or foreign travelers for recreational or other purposes; fish or shellfish could not be taken and sold in interstate or foreign commerce; and/or could not be used for industrial purposes by industries in interstate commerce. Therefore, WTL-1 is not a jurisdictional water of the U.S.

The feature identified as D-1 is a 118' reach of a drainage channel located along the southern property boundary. The drainage channel was observed during the November 21, 2016 onsite visit. In historical aerials (dated 1997), it appears an old farm road or logging road was in the vicinity of the drainage channel. Wetland characteristics were not present in the drainage channel thus, it lacks the criterion required for a jurisdictional wetland. The flow of the drainage channel would be characterized by low volume, infrequent, and short duration flow insufficient enough to establish an OHWM thus, it lacks the criterion required for a jurisdictional tributary. Therefore, D-1 is not a jurisdictional water of the U.S. Additionally, D-1 does not flow directly or indirectly into a TNW or is connected to interstate or foreign commerce. The feature is not used by interstate or foreign travelers for recreational or other purposes; fish or shellfish could not be taken and sold in interstate or foreign commerce; and/or could not be used for industrial purposes by industries in interstate commerce. Therefore, D-1 is not a water of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

WTL-1 is a geographically isolated feature that does not have any surface inlet or outlets with no hydrologic connectivity to other waters including TNWs. The feature D-1 does not have stream characteristics such as an OHWM and does not have hydrologic connectivity to

other down gradient waters including TNWs thus, is not a jurisdictional water. No surface water was observed within or leaving any portion of the features during the consultant's assessments in October 2016 and February 2017 nor during RD's onsite inspection on 21 November 2016. Neither WTL-1 or D-1 flow directly or indirectly into a TNW or are connected to interstate or foreign commerce. These features are not used by interstate or foreign travelers for recreational or other purposes; fish or shellfish could not be taken and sold in interstate or foreign commerce; and/or could not be used for industrial purposes by industries in interstate commerce. Therefore, WTL-1 or D-1 are not waters of the U.S.
