C. PROJECT LOCATION AND BACKGROUND INFORMATION: The subject site is located in a rural area on the west side of County Road 164 in Moulton, Lawrence County, Alabama. The project area may be found on the Masterson, ALA USGS Topo Map (Section 16, Township 6 S, Range 8 W). A site visit was conducted on August 4, 2016 to review potential waters of the U.S. in a defined area on the property. The review area is located on a farm used for the production of cattle and poultry. The review area is adjacent to and at the southern end of the seven existing poultry barns. The review area may be described as pasture land with scattered trees that is gently sloped with a grassy swale. The grassy swale is the only potential waters feature that was identified on the property.

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: A site visit was conducted on August 4, 2016 to inspect the review area. Located in the middle of the review area is a grassy swale that displays no ordinary high water mark indicators. No hydrology or soil indicators were observed from a soil sample taken from the lowest part of the grassy swale. Based on information submitted by Ms. Sharon Thompson, AST Consulting and Contracting, LLC and field visit, it has been determined the grassy swale is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
