Creek. The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page 41217), states "For clarification, it should be noted that we generally do not consider the following waters to be Waters of the United States.... (a) non-tidal drainage and irrigation ditches excavated on dry land." Based on a review of information submitted by BDY Environmental LLC on July 19, 2017, including aerial photography dated July 18, 2017, a USGS quadrangle map, NRCS Soil Maps for Davidson County, State, soil samples, a review of the National Hydrologic Dataset, U.S. Fish and Wildlife National Wetland Inventory database, wetland data sheets from Eastern Mountain and Piedmont Regional Supplement to the 1987 Wetland Delineation Manual (Version 2.0), photographs of the project site, and a site inspection of the survey area on August 29, 2017, I have determined WC-A is not a waters of the U.S. and is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

Wetland 1 measures approximately 0.053 acre and is located near the center of the site (N 36.261699, W -86.753934). The feature is located 560 feet from North Fork of Ewing Creek, which is the nearest watercourse. The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page 41217), states "For clarification, it should be noted that we generally do not consider the following waters to be "Waters of the United States.... (c) artificial lakes and ponds created by the excavation and/or diking of dry land to collect and retain water which are used exclusively for such purposes as stock watering, irrigation, settling basins or rice growing." Based on a review of information submitted by BDY Environmental LLC on July 19, 2017, including aerial photography dated July 18, 2017, a USGS quadrangle map, NRCS Soil Maps for Davidson County, State, soil samples, a review of the National Hydrologic Dataset, U.S. Fish and Wildlife National Wetland Inventory database, wetland data sheets from Eastern Mountain and Piedmont Regional Supplement to the 1987 Wetland Delineation Manual (Version 2.0), photographs of the project site, and a site inspection of the survey area on August 29, 2017, I have determined Wetland 1 is not a waters of the U.S. and is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

WC-D is located on the southern boundary of the property (36.261581, -86.754795) WC- did not meet the definition of a wetland and lacked lateral limits of jurisdiction. No OHWM indicators were observed. DF-1 does not meet the definition of a waters of the United States (WOUS) as defined by 33 CFR Part 328.

WC-E is located on the southern boundary of the property (36.261751, -86.754651) WC-E did not meet the definition of a wetland and lacked lateral limits of jurisdiction. No OHWM indicators were observed. DF-1 does not meet the definition of a waters of the United States (WOUS) as defined by 33 CFR Part 328.

WC-F is located on the northern boundary of the property (36.262584, -86.754341) WC-F did not meet the definition of a wetland and lacked lateral limits of jurisdiction. No OHWM indicators were observed. DF-1 does not meet the definition of a waters of the United States (WOUS) as defined by 33 CFR Part 328.

WC-G is located on the eastern section of the property (36.262702, -86.753652) WC-G did not meet the definition of a wetland and lacked lateral limits of jurisdiction. No OHWM indicators were observed. DF-1 does not meet the definition of a waters of the United States (WOUS) as defined by 33 CFR Part 328.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
