Explain: **PND-1: This feature, located within the "AJD Review Area", is an approximately 0.51 acre non-jurisdictional artificial pond created by excavating and/or diking dry land to collect and retain water and is used exclusively for livestock watering. During the 2/28/2022 and 3/1/2022 site visit, USACE determined that PND-1 is an artificial pond constructed entirely in uplands. The pond is located near the top of a hill and has no observable jurisdictional or non-**

jurisdictional hydrology input. Additionally, USACE determined that the intended purpose of this pond is for livestock watering based on the presence of cattle during the site visit as well as the heavily browsed vegetation and compacted soil along the perimeter of the artificial pond. During a desktop review of the feature, USACE confirmed the lack of hydrologic connection to upstream or downstream waters. The feature was also determined to be located on a hillside; an unnatural topographic position. Therefore, the USACE has determined that this feature is a non-jurisdictional artificial pond created by excavating and/or diking dry land to collect and retain water and is used exclusively for livestock watering and is not waters of the U.S. as outlined in the preamble of the November 13, 1986 Federal Register (51 FR 41217). The feature does not carry a relatively permanent flow to downstream traditional navigable waters. Accordingly, PND-1 is determined to be a non-jurisdictional artificial pond excavated in dry lands. The feature is depicted on the attached map "LRN-2017-01041, TDOT PIN 101293.02, AJD MAP"

PND-6: This feature, located within the "AJD Review Area", is an approximately 0.18 acre non-jurisdictional artificial pond created by excavating and/or diking dry land to collect and retain water and is used exclusively for livestock watering. During the 2/28/2022 and 3/1/2022 site visit, USACE determined that PND-6 is an artificial pond constructed entirely in uplands. The pond is located along a hillside and has no observable jurisdictional or non-jurisdictional hydrology input. An earthen berm that forms the pond has failed recently and below the headcut there is a small swale that lacks Ordinary High Water Mark. Additionally, USACE determined that the intended purpose of this pond is for livestock watering based on the location of the artificial pond in a cattle pasture as well as the disturbed vegetation, hoof prints, and compacted soil. During a desktop review of the feature, USACE confirmed the lack of hydrologic connection to upstream or downstream waters. The feature was also determined to be located on a hillside; an unnatural topographic position. Therefore, the USACE has determined that this feature is a non-jurisdictional artificial pond created by excavating and/or diking dry land to collect and retain water and is used exclusively for livestock watering and is not waters of the U.S. as outlined in the preamble of the November 13, 1986 Federal Register (51 FR 41217). The feature does not carry a relatively permanent flow to downstream traditional navigable waters. Accordingly, PND-6 is determined to be a non-jurisdictional artificial pond excavated in dry lands. The feature is depicted on the attached map "LRN-2017-01041, TDOT PIN 101293.02, AJD MAP"

EPH-1: This feature, located within the "AJD Review Area", is an approximately 104 linear feet non-jurisdictional erosional feature characterized by low volume, infrequent, or short duration flow). During the 2/28/2022 and 3/1/2022 site visit, USACE determined that the erosional feature EPH-1 lacked consistent indicators of Ordinary High Water Mark (OHWM) as described in 33 CFR 328.3(e). The short erosional feature is located behind a residential home and dissipates entirely to sheet flow where the slope becomes more gradual and the erosional feature goes from the wood-line to a pasture. The feature does not carry a relatively permanent flow to downstream traditional navigable waters. Accordingly, EPH-1 is determined to be a non-jurisdictional "swale or erosional feature (e.g., gullies, small washes characterized by low volume, infrequent, or short duration flow)" as outlined in the *Rapanos v. United States and Carabell v. United States* decision. The feature is depicted on the attached map "LRN-2017-01041, TDOT PIN 101293.02, AJD MAP"

PND-1, PND-6, and EPH-1 were examined, including a review of: maps/plans submitted by the applicant, USGS topographical survey maps, aerial photographs, the USGS National Hydrography Dataset, USGS StreamStats, Google Earth Pro, Lidar imagery from the USACE Nashville Regulatory Viewer, and observations recorded during the site inspection on 2/28/2022 and 3/1/2022. It has been determined that the PND-1 and PND-6 features are non-jurisdictional artificial ponds excavated in dry land and that EPH-1 is a non-jurisdictional erosional feature. These features are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. In conclusion, there are no aquatic resources within the approved jurisdictional determination survey area that meet the definitions of waters of the U.S. as listed in 33 CFR Part 328.3(a).

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
