C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

F. NON-JURISDICTIONAL WATERS, INCLUDING WETLANDS (CHECK ALL THAT APPLY):

- If potential wetlands were assessed within the review area, these areas did not meet the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or appropriate Regional Supplements.

- Other: (explain, if not covered above): **EPH-1 is an approximately 861 feet long feature located within the review area. The feature is not a tributary and does not carry a relatively permanent flow to downstream traditional navigable waters. Within the review area, the feature begins near the outlet of an existing culvert crossing beneath England Industrial Road. The feature drains southward alongside England Industrial Road and then westward along SR-33 to an existing culvert crossing beneath SR-33. During an on-site investigation of site conditions on July 11, 2018, the feature was observed to have wracking, bed/banks, and a lack of vegetation within the reaches described above. Based on available aerial imagery, it appears that the catchment/watershed of the existing culvert crossing beneath England Industrial Road is comprised largely of an industrial park resulting in flashy stormwater-driven hydrologic characteristics able to transport woody and other debris and maintain a vegetation-free area and bed/banks within the conveyance. Downstream of the culvert crossing beneath SR-33, all ordinary high water mark indicators quickly dissipate, and no channel or discrete conveyance was observed for a distance of 100+ feet to the next downgradient water feature. The absence of a surface channel or discrete conveyance below the culvert crossing beneath SR-33 is supported by available aerial imagery. EPH-1 is an erosional feature characterized by low volume, infrequent, and short duration flow. The USACE examined maps/plans submitted by the applicant, USGS maps, aerial photographs, the National Hydrography Dataset, and observations recorded during the on-site investigation. It has been determined that the feature is not a tributary and does not contribute flow directly or indirectly to downstream traditional navigable waters. The feature is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. The feature is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a) because it lacks a link to interstate or foreign commerce sufficient to serve as a basis for jurisdiction. In conclusion, there are no aquatic resources within the approved jurisdictional determination survey area that meet the definition of waters of the U.S. as found at 33 CFR Part 328.3(a).**
