PROJECT LOCATION AND BACKGROUND INFORMATION: The approved jurisdictional (AJD) review area A consists of approximately 277 acres located southeast of the Interstate 65/Huntsville Browns Ferry Road Interchange and west of Dogwood Flat Road. AJD Review Area A consists mostly of open fields but with some small forested areas. The majority of the forested areas consist of abandoned tree nursery stands with trees growing in rows with furrows between these rows. No tributaries exist within AJD review area A, but a man-made ditch is present that carries water generally from north to south. This AJD form references all waters found within AJD Review Area A which includes seven isolated wetlands.

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Seven wetlands exist within the AJD review area. Each wetland listed below is geographically isolated with no hydrological connection to other waters.

Based on a review of information submitted by the wetland delineator, including: a USGS quadrangle map, NRCS Soil Maps for Limestone County, Alabama, a review of the National Hydrologic Dataset, U.S. Fish and Wildlife National Wetland Inventory database, and photographs of the review area; the Corps has determined the seven wetlands listed below are not part of a tributary system to interstate or navigable waters of the United States and are not adjacent to such tributary waters.

The wetlands do not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. The wetlands are determined to not be jurisdictional under the CWA because the wetlands lack links to interstate commerce sufficient to serve as a basis for jurisdiction. In consideration of the January 2, 2001, United States Supreme Court decision, Solid Waste Agency of Northern Cook County v. United States Army Corps of Engineers, we have determined the wetlands listed below are isolated and not jurisdictional under Section 404 of the CWA.

significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
