C. PROJECT LOCATION AND BACKGROUND INFORMATION: The approved jurisdictional (AJD) review area consists of approximately 1 acre located immediately west of a private road identified as Doss Circle, west of the Paradise Lane intersection, south of U.S. Highway 43. The USGS topographic map indicates no waters present within the AJD review area. The AJD review area consists of an area historically utilized as a soil borrow pit excavated within uplands that currently contains a mixture of early-successional forest and herbaceous vegetation. No tributaries exist within the AJD review area. This AJD form references all waters found within the AJD review area which include two depressional wetlands (WB and WC). The AJD review area is associated with a much larger jurisdictional determination area being processed with a preliminary JD.

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Two wetlands (WB and WC) exist within the AJD review area. WB (0.21 acre) and WC (0.04 acre) are depressional wetlands that were created within NRCS-mapped non-hydric soil series (Bodine gravelly silt loam with 12-30 percent slopes), incidental to the use of the land as a soil borrow pit. The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page 41217), states, "For clarification, it should be noted that we generally do not consider the following waters to be "Waters of the United States... (e) Waterfilled depressions created in dry land...for the purpose of obtaining fill..."**

Based on a review of information submitted by Terracon on January 19, 2022, including: a USGS quadrangle map, NRCS Soil Maps for Lauderdale County, Alabama, U.S. Fish and Wildlife National Wetland Inventory database, and photographs of the review area; the Corps has determined WB and WC are not waters of the U.S. and are not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
