C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

On 7-Feb-2020, COE personnel visited the subject location to verify features shown in the Jurisdictional Determination Report dated 22-Nov-2019. The site visit was requested by Brushy Fork Environmental, Inc., the consultant for Realty Income Corporation. The property is located at 2404 Memorial Blvd in Kingsport, Tennessee which is north and east of Memorial Blvd and Jesse Street. The waters report stated the survey area to be 3.09 acres in size. A review of 1999 to 2015 online aerial photography available from Google Earth shows this has been fully paved and development for this period. No features are visible on aerial photography. The Jurisdictional Determination Report identified one possible wetlands and no streams on the site. The National Hydrography Dataset and National Wetland Inventory showed no features within the survey boundary. . The feature identified in the report was found to be a storm water detention basin located at the north east corner of the site. The only water source for this basin was storm drain from the parking lot and roof top runoff piped from an adjoining industrial building. The basin has one effluent pipe that takes stormwater in a southern direction toward Memorial Blvd. The feature was found to be approximately 0.02 acre. No surface stream flows or groundwater inputs was seen for this feature. The only water source appeared to be stormwater from storm drains and roof top gutters. This feature was determined to isolated from downstream waters and is not be waters of the U.S.
