- B. Typical year assessment(s):** The Corps field visit on June 25, 2020 was conducted in normal conditions in the dry part of the growing season. The consultant completed a field visit on June 26, 2018 in normal conditions in the dry part of the growing season.
- C. Additional comments to support AJD:** The project area surveys consisted mostly of flat bedrock. Ephemerals previously identified by the consultant were found to be vegetated over due to the construction to the east of the property, showing no characteristics of OHWM. Many sinkholes are present on site, fed by sheet flow from the surrounding area. The wetlands identified above, are connected via sheet flow over bed rock and groundwater discharge. Wetland 2 and 3 were determined to be isolated, connected only to other resources via sheet flow over bedrock. Wetland 1 may be connected via flooding to a drainage ditch along Fall Creek Rd, however, this ditch did not meet definitions of an A1 or A2 water, therefore Wetland 1 is nonjurisdictional.
