S5 was determined to be an ephemeral ditch constructed along Old Freewill Drive NW. The feature is not a relocated tributary and does not contribute directly or indirectly to an A(1) or A(2) water. S5 does not relocate a tributary, is not constructed in a tributary, and is not constructed in an adjacent wetland. The nearest visible stream is an intermittent stream, UT to UT to Candies Creek, which is connected via a culvert under Old Freewill Drive NW, and is approximately 30 linear feet to the east.

B. Typical year assessment(s): The Antecedent Precipitation Tool was used to evaluate the project area for the previous 90 days, with a date of June 24, 2020. A single point centered on the center of the project site was used to evaluate the rainfall data and was determined to be sufficient based on the small geographic size of the site. The 90 day period beginning April 25, 2020 was determined to be wetter than normal and the rainfall exceeded the 70th percentile, for all three 30 day periods. The drought index further describes the period as extreme wetness and the rainfall for the previous 30 days exceeded the 30-year rolling. The site also received 0.5" of rainfall within the previous 48 hours. No flow was observed in S5 and the reach was determined to be an ephemeral roadside ditch constructed in uplands.
