- B. Typical year assessment(s):** The ACOE field visit was conducted on June 25, 2020, in normal conditions in the dry part of the growing season according to the APT. The consultant site visit was conducted on April 21, 2020 in wetter than normal conditions in the wet part of the growing season.
- C. Additional comments to support AJD:** All resources were verified on site on June 25, 2020. D-1 was determined ephemeral due to little to no channel being present and no groundwater input observed. Wetland A and B were both determined to be isolated due to the ephemeral stream they are connected by. Pond A was constructed in uplands, had steep sides, and no surface connection was observed during the site visit.
