Channel 2 does not relocate a tributary, is not constructed in a tributary, and is not constructed in an adjacent wetland. The nearest visible stream is Sinking Creek.

B. Typical year assessment(s): [The Antecedent Precipitation Tool was used to evaluate the project area for the previous 90 days, with a date of June 29, 2020. A single point centered on the center of the project site was used to evaluate the rainfall data and was determined to be sufficient based on the small geographic size of the site. The 90 day period beginning March 25, 2020 was determined to have normal conditions for the site, and rainfall in the 30 days preceding June 29, 2020 was in the 30-year normal range.](#)
