**B. Typical year assessment(s):** The Antecedent Precipitation Tool (APT) was used to evaluate the project area for the months preceding my 15 September 2020 site inspection. A single point centered on the AJD review area was used to evaluate the rainfall data. The 90 day period preceding 15 September 2020 was determined to be normal with the nearest 30-day period being wetter than the 70th percentile, the month ending 30 days prior to 15 September 2020 drier than the 30th percentile, the month ending 60 days prior

These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.
