- B. Typical year assessment(s):** The Antecedent Precipitation Tool was used to evaluate the project area for the previous 60 days, with a date of December 3, 2020. A single point centered on the center of the project site was used to evaluate the rainfall data and was determined to be sufficient based on the small geographic size of the site. The 60-day period beginning December 3, 2020 was determined to be normal conditions. The drought index further describes the period as extreme wetness and the rainfall for the previous 30 days was less than the 30-year rolling. Flow was observed from the wetland to the abutting a(2) water.
- C. Additional comments to support AJD:** Applicant stated wetland continues offsite and beyond survey area to the east.
