WWC1	625	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	WWC1 was determined to be an ephemeral feature, flowing for approximately 625 linear feet through the 3.5 acre review area. No flow was observed in the channel of WWC1 during the September 28, 2020 site visit conducted by the applicant. APT documented the prior 3 months as wetter than normal, with August and September having rainfall greater than the 70th percentile. A review of the USGS 24K NHD layer does not have WWC1 mapped. The lack of water and habitat, and JD report submitted by applicant documenting a dry channel during the 9/28/2020 site visit indicate WWC1 is an ephemeral stream.

B. Typical year assessment(s): The Antecedent Precipitation Tool was used to evaluate the project area for the previous 90 days, with a date of September 28, 2020, to coincide with the submitted delineation report. A single point centered on the center of the project site was used to evaluate the rainfall data and was determined to be sufficient based on the small geographic size of the site. The 90 day period beginning September 28, 2020 was determined to be wetter than normal and the rainfall exceeded the 70th percentile, for August and September.
