The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

### C. SIGNIFICANT NEXUS DETERMINATION

Proximity:

The AJD review area covers the entirety of the relevant reach (RR). The RR is 322 linear feet and has an approximate drainage area of 2.13 acres, making up 0.00001189% of the 179,151 acres of the East Fork Stones River watershed at the point where any contribution from this RR might enter the East Fork Stones River (confluence), as determined by the USGS Stream Stats tool. The RR is 8.5 river miles from the East Fork Stones River. The flow path is described in section B(1)(ii).

Flow Characteristics:

Precipitation in Rutherford County averages 54 inches annually. The RR only flows in response to rain events and the duration of that flow is contained to fewer than 7 days following the rain event. We infer that any contribution of water or material by the RR to the East Fork Stones River is negligible based on the relative size of its watershed compared to that of the East Fork Stones River.

Quality:

EPA's 303(d) list of impaired waters in NHD maps do not include areas within the RR or any of the receiving waters leading to the East Fork Stones River. The RR does not have any wetlands associated with it.

Relevant Reach Function:

The primary functions of the RR are the collection and distribution of stormwater, sediment, organic matter, and nutrients to downstream systems, which occur only during or immediately after precipitation events that produce runoff. The volume of water conveyed by the RR and the amount of substances entrained within this water are negligible in proportion to that delivered to the downstream TNW. The habitat of the RR does not support organisms inhabiting the TNW. The ephemeral habitat of the RR and its distance to the TNW (approximately 8.5 river miles), precludes its use by aquatic life present in the TNW for foraging, breeding, or refugia.

Determination:

We have concluded from our analysis that any effect of this RR's functions on the chemical, biological, or physical integrity of the downstream TNW is negligible, and we therefore cannot assert that the RR, "ES 1", has more than a speculative or insubstantial effect on the chemical, physical, and biological integrity of the East Fork Stones River. We conclude that a significant nexus does not exist between "ES 1" and the East Fork Stones River.
