- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Ditch 1 is approximately 326.9 linear-foot non-jurisdictional non-tidal drainage ditch excavated on dry land, located within the review area. The USACE has determined that this feature is a non-tidal drainage ditch excavated on dry land and is not waters of the U.S as outlined in the preamble of the November 13, 1986, Federal Register (51 FR 41217). The feature is not a tributary and does not carry a relatively permanent flow to downstream traditional navigable waters. The feature is excavated wholly in and draining only uplands. Flow begins at 36.8386 -84.0321 and**

discharges to 36.838965 -84.031790. Accordingly, Ditch 1 is determined to be a non-jurisdictional non-tidal drainage ditch excavated in dry land and is not a tributary.

Pond D is a manmade impoundment created in uplands between 1997 and 2004 (according to Google Earth aerial imagery) to support agriculture. The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page 41217), states "For clarification, it should be noted that we generally do not consider the following waters to be "Waters of the United States.... (c) artificial lakes and pond created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing and is not waters of the U.S as outlined in the preamble of the November 13, 1986, Federal Register (51 FR 41217). The feature is excavated wholly in and draining only uplands. Pond D is determined to be a non-jurisdictional impoundment excavated in dry land and is not a jurisdictional impoundment.

Pond D outlet is an ephemeral channel located at the outflow of Pond D. Pond D outlet is approximately 105 linear feet in length. The nearest tributary is located 46 LF from the downstream terminus of Pond D outlet. This feature does not appear on USGS Topographic Maps, USGS NHD Maps, USDA Bell County Soil Survey Maps or the National Wetlands Inventory (NWI) maps. Pond D outlet lacks a connection to downstream waters. The stream does not carry flow directly or indirectly into a traditional navigable water. Therefore, the feature does not meet the definition of a tributary. I have determined Pond D outlet is not a water of the U.S. and is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
