Explain: **EPH-11: This feature is an approximately 1,469 linear foot non-jurisdictional non-tidal drainage ditch excavated on dry land, located within the review area. This feature was originally delineated by the environmental consultant Stantec, on behalf to Tennessee Department of Transportation (TDOT), to be three separate features; EPH-11 (336 linear feet; ephemeral), EPH-12 (629 linear feet; ephemeral), and STR-3 (504 linear feet; intermittent).**

Following the 3/16/2022 and 3/17/2022 site visit, USACE determined that STR-3 does not carry a relatively permanent flow and is constructed in the uplands within the toe of the the Tennessee State Route 8 road-slope. Additionally, USACE determined that the three aforementioned features are one continuous ephemeral roadside ditch. The feature originates within the roadside ditch, and no portion is located in a topographic valley. Therefore, the USACE has determined that this feature is a non-tidal drainage ditch excavated on dry land and is not waters of the U.S. as outlined in the preamble of the November 13, 1986 Federal Register (51 FR 41217). The feature does not carry a relatively permanent flow to downstream traditional navigable waters. The ephemeral feature is located within the toe of the SR-8 slope and is excavated wholly in and drains only uplands. Accordingly, EPH-11 is determined to be a non-jurisdictional non-tidal drainage ditch excavated in dry lands. The feature is depicted on the attached map "LRN-2021-00270, TDOT PIN 124080.00, AJD MAP"

EPH-11 was examined, including a review of: maps/plans submitted by the applicant, USGS topographical survey maps, aerial photographs, the USGS National Hydrography Dataset, USGS StreamStats, and observations recorded during the site inspection on 3/16/2022 and 3/17/2022. It has been determined that these features are non-jurisdictional non-tidal drainage ditches excavated in dry land. These features are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. In conclusion, there are no aquatic resources within the approved jurisdictional determination survey area that meet the definitions of waters of the U.S. as listed in 33 CFR Part 328.3(a).

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
