Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **Stream 2A is an intermittent feature that flows 194 feet across an abandoned mining bench. During the field investigation on March 30, 2022, OHWM consisting of bed and bank, scour, and sediment sorting was observed throughout the reach until the stream left the mining bench. The nearest stream is located over 800 feet downslope, but there was no indicators of hydrologic connection observed between these features and Stream 2A. The stream does not carry flow directly or indirectly into a traditional navigable water.**

Therefore, the feature does not meet the definition of a tributary. Also, the feature does not meet the definition of a wetland. This feature is not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. The feature is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a) because they lack a link to interstate or foreign commerce sufficient to serve as a basis for jurisdiction. In conclusion, there are no aquatic resources within the approved jurisdictional determination survey area that meet the definitions of waters of the U.S. as listed in 33 CFR Part 328.3(a). I have determined Stream 2A is not a water of the U.S. and is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFRPart 328.3(a).

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
