Aerial imagery dating from 1950 depicts the ponds were not present and there is no indication that the areas were wetlands or streams. Per 33 CFR Part 328.3(b) "Artificial lakes and ponds created by the excavation and/or diking of dry land to collect and retain water which are used exclusively for such purposes as stock watering...". I have determined Pond-1, and Wetland-1 are not waters of the U.S. and are not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).**
