considers EPH-1 a non-tributary and not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

Wetland-1 is a palustrine emergent wetland situated in a depression. Overflow was observed through sheetflow through uplands, which ended in a non-wetland depression approximately 125' to the south. This area did not have hydric soils or hydrophytic vegetation and evidence of sheetflow from this area was not observed. Wetland-1 does not drain directly or indirectly to any waters of the United States and do not support a link to interstate or foreign commerce, because it is not known to be used by intersate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in intersate or foreign commerce and is not known to be used for industrial purposes by industires in interstate commerce. The USACE considers Wetland-1 be isolated and non-jurisdictional under §404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**
