purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce and is not known to be used for industrial purposes by industries in interstate commerce. LiDAR/DEM maps and site visits have confirmed that the resource is bermed, with no outlet. The USACE considers this aquatic feature isolated and non-jurisdictional under Section 404 of the CWA.

Pond 2 and Pond 3 were verified as excavated farm ponds that been dug out for irrigation purposes associated with agriculture. The ponds were dug in uplands and drain only uplands. The ponds can be seen on imagery from 1980, and not in 1957. The ponds were verified to have no outlet and no connection to surface water down gradient. These waters meet the definition of non-jurisdictional waters listed in 40 CFR § 120.2, “Artificial lakes and ponds, including water storage reservoirs and farm, irrigation, stock watering, and log cleaning ponds, constructed or excavated in upland or in non-jurisdictional waters...”.

Wetland A does not drain directly or indirectly to any waters of the U.S. and does not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce and is not known to be used for industrial purposes by industries in interstate commerce. LiDAR/DEM maps and site visits have confirmed that the resource is bermed, with no outlet. The USACE considers this aquatic feature isolated and non-jurisdictional under Section 404 of the CWA.

Wetland B does not drain directly or indirectly to any waters of the U.S. and does not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce and is not known to be used for industrial purposes by industries in interstate commerce. LiDAR/DEM maps and site visits have confirmed that the resource is bermed, with no outlet. The USACE considers this aquatic feature isolated and non-jurisdictional under Section 404 of the CWA.

Wetland C does not drain directly or indirectly to any waters of the U.S. and does not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce and is not known to be used for industrial purposes by industries in interstate commerce. Wetland C was verified on site to flow southward toward an intermittent stream, which runs into a sinkhole. No evidence found suggests that water flows on past the sinkhole area. The USACE considers this aquatic feature isolated and non-jurisdictional under Section 404 of the CWA.

D-16 is not considered a tributary as it does not have a direct or indirect connection to a TNW. D-16 is an ephemeral feature that flows south into Wetland A. Wetland A was verified to be an isolated feature with no outlet.

D-18 is not considered a tributary as it does not have a direct or indirect connection to a TNW. D-18 is an intermittent feature that was verified onsite to flow into a sinkhole. There was no indication that any flow continues past the sinkhole area.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
