Pond A and Wetland A do not drain directly or indirectly to any waters of the U.S. and do not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken**

and sold in interstate or foreign commerce and is not known to be used for industrial purposes by industries in interstate commerce. The USACE considers these aquatic features isolated and non-jurisdictional under Section 404 of the CWA. One isolated feature, Wetland-A (0.30 acres) is a low, depressional wetland area that is expected to have formed from highway construction and agricultural disturbances (row-cropped). Hydrology is from stormwater runoff of the field slopes and captured in the shallow, depressional area. There are no inlet or outlet drainage features of the wetland area and it does not connect to any other water features. Pond-A (0.49 acres) is an open water, isolated feature that is man-made by excavation in uplands with side-casting. There are no inlet or outlet drainage features to the pond and it was not constructed within a tributary nor wetland.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
