The AJD review area consists of a maintained roadside ditch/swale containing herbaceous vegetation. No tributaries exist within the AJD review area. This AJD form references all waters found within the AJD review area which includes one isolated wetland (WB). The AJD review area is associated with a much larger jurisdictional determination area being processed with a preliminary JD.

maintained highway roadside ditch/swale. WB is geographically isolated, approximately 0.7 of a mile from the nearest known tributary (Taylor Creek). A portion of WB is located within the NRCS-mapped hydric soil series (Guthrie), a listed hydric soil. The USFWS NWI map designates WB as a PFO1A wetland. A concrete pipe culvert exists under U.S. Highway 41A that allows water from WB to drain to the north under the highway.

Based on a review of information submitted by Lord & Winter LLC on behalf of the Elk River Public Utility District - Estill Springs, including: a USGS quadrangle map, NRCS Soil Maps for Franklin County, Tennessee, a review of the National Hydrologic Dataset, U.S. Fish and Wildlife National Wetland Inventory database, and photographs of the review area; the Corps has determined WB is not part of a tributary system to interstate or navigable waters of the United States and is not adjacent to such tributary waters.

The wetland does not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. The wetland is determined to not be jurisdictional under the CWA because the wetland lacks links to interstate commerce sufficient to serve as a basis for jurisdiction.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
