C. PROJECT LOCATION AND BACKGROUND INFORMATION: The approved jurisdictional (AJD) review area consists of approximately 43 acres located at the eastern end of Finney Drive SW. The USGS topographic map indicates no waters present within the AJD review area. Recent Google Earth imagery (2019) reveals a pond constructed within uplands in the AJD review area. The pond is within a larger area that appears to be a borrow pit, possibly borrowing soil for a new development on the north side of Finney Drive SW. A 14 December 2021 site visit confirmed the presence of the pond and the disturbed earth surrounding it.

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **One pond (P-1) exists within the AJD review area. P-1 is a 0.24 acre excavated pond. P-1 first appears on Google Earth imagery dated 1 February 2019 but was not present on imagery dated 15 February 2017. P-1 was excavated in NRCS-mapped non-hydric soil series, Decatur silty clay loam, 2 to 6 percent slopes, eroded. The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page 41217), states, "For clarification, it should be noted that we generally do not consider the following waters to be "Waters of the United States... (e) Waterfilled depressions created in dry land... for the purpose of obtaining fill..."**

Based on a review of information submitted by Terracon on 18 October 2021, including: a USGS quadrangle map, NRCS Soil Maps for Madison County, Alabama, U.S. Fish and Wildlife National Wetland Inventory database, photographs of the project site, site inspections on 12 May 2021, of the property, which reveal P-1 was created within dry land. The Corps has determined P-1 is not a water of the U.S. and is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
