Explain: **Six potential tributaries were inspected during the USACE 1 March 2022 site inspection. Two of these features are indicated on the USGS topographic quadrangle map with "blue-lines" but the site visit revealed these are located in agricultural row-cropped fields and lack any ordinary high water marks (OHWM) and are therefore not**

tributaries. Four other drainage features that are not "blue-line" features (UDF-1, UDF-2, UDF-3, and UDF-4), but are upland gullies on the landscape immediately west of Flint River were inspected during the 1 March 2022 site visit. There are segments of these features that have well-defined channels but lack an OHWM. 5.86 inches of rain had fallen at the site within eight days of the USACE site visit, including 0.49 of rain two days before the site visit and yet there was not water in any of the channels. Based on a review of information submitted by Pegrum Creek, LLC's agent on 18 January 2022, including: a USGS quadrangle map, NRCS Soil map, U.S. Fish and Wildlife National Wetland Inventory map, photographs of the project site, and a USACE site visit on 1 March 2022, the USACE has determined none of these six potential tributaries are tributaries and are therefore not a water of the U.S. and not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
