Explain: **The site property is entirely surrounded by roads and a railroad and there is no outlet for waters. WA is a 0.74-acre pond excavated wholly in uplands. WB is a 0.09-acre depression area likely an excavated borrow area for construction of railroad and/or road. WC-Linear Wetland is a 178-SQ-FT feature where water collects between the railroad and the berm of WA and has no outlet. The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page 41217), states "For clarification, it should be noted that we**

generally do not consider the following waters to be "Waters of the United States.... (c) artificial lakes and ponds created by the excavation and/or diking of dry land to collect and retain water which are used exclusively for such purposes as stock watering, irrigation, settling basins or rice growing. (e) Waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and the resulting body of water meets the definition of Waters of the U.S." Based on a review of information submitted by Lord & Winter, LLC Consultants on February 11, 2022, including: aerial photography, a USGS quadrangle map, NRCS Soil Maps, a review of the National Hydrologic Dataset, U.S. Fish and Wildlife National Wetland Inventory database, wetland data sheets from Eastern Mountain and Piedmont Regional Supplement to the 1987 Wetland Delineation Manual (Version 2.0), photographs of the project site, and a site inspection of the survey area on March 8, 2022, I have determined POTENTIAL WATERS are not waters of the U.S. and are not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a) .

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
