dry land to collect and retain water which are used exclusively for such purposes as stock watering, irrigation, settling basins or rice growing...(d) Artificial reflecting or swimming pools or other small ornamental bodies of water created by excavating and/or diking dry land to retain water for primarily aesthetic reasons”. Based on available aerial photography there is no indication that the area was wetland or stream. The nearest mapped surface water is an unnamed tributary to Blackburn Fork that is located approximately 1,040 feet to the southeast. Based on a review of information submitted by BDY Environmental, LLC on February 18, 2022, including aerial photography, NRCS Soil Maps, remote sensing tools available in the National Regulatory Viewer and a review of the National Hydrologic Dataset, U.S. Fish and Wildlife National Wetland Inventory database, photographs of the project site, I have determined Wetland A is a 0.26 acre farm pond is not a waters of the U.S. and is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
