WTL-1 (0.10 acre) was determined to be an isolated resource. WTL-1 does not drain directly or indirectly to any waters of the U.S. and does not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; it does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce and is not known to be used for industrial purposes by industries in interstate commerce. LiDAR/DEM maps, historical imagery, previous disturbance, and previous documentation have confirmed that the resource is isolated from the other resources on site, with no outlet for flow. The USACE considers this aquatic feature isolated and non-jurisdictional under Section 404 of the CWA.

WWC-6 – 119 linear feet, WWC-7 – 110 linear feet, WWC-8 – 136 linear feet, WWC-9 – 214 linear feet, WWC-10 – 80 linear feet are not considered tributaries as they do not have a direct or indirect connection to a TNW. These features flow into various sinkholes on the property, many of which were verified on site. Using LiDAR/DEM mapping and aerial imagery it was determined that these features do not reach a TNW. These resources do not support a link to interstate or foreign commerce, because they are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce and are not known to be used for industrial purposes in interstate commerce. These features are not considered WOTUS because they are not tributaries.

PND-1 (0.30 acre) - The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page 41217), states "For clarification, it should be noted that we generally do not consider the following waters to be "Waters of the United States.... (c) artificial lakes and ponds created by the excavation and/or diking of dry land to collect and retain water which are used exclusively for such purposes as stock watering, irrigation, settling basins or rice growing."

Based on aerial photography dated 1951, USGS quadrangle map, NRCS Soil Maps, a review of the National Hydrologic Dataset, U.S. Fish and Wildlife National Wetland Inventory database) I have determined PND-1 is not waters of the U.S. and is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
