and ponds created by the excavation and/or diking of dry land to collect and retain water which are used exclusively for such purposes as stock watering, irrigation, settling basins or rice growing.”

Based on a review of information submitted by CEC, aerial photography, a USGS quadrangle map, NRCS Soil Maps, a review of the National Hydrologic Dataset, U.S. Fish and Wildlife National Wetland Inventory database, photographs of the project site, the landscape position, I have determined that PND-1 is not waters of the U.S. and is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

WWC-1 (76 linear ft) is not considered a tributary as it does not have a direct or indirect connection to a TNW. This feature flows into a sinkhole on site. The site was verified to have many sinkholes throughout the entire review area. Using LiDAR/DEM mapping and aerial imagery it was determined that this feature does not reach a TNW. The resource does not support a link to interstate or foreign commerce, because it is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce and is not known to be used for industrial purposes in interstate commerce. WWC-1 is not considered WOTUS because it is not a tributary.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
