WWC-2 (124 linear ft): This feature was determined on site to have been formed due to the concentration of water entering a culvert crossing put over an upland drainage swale. No evidence of OHWM was present above or below the section delineated. Nonhydryc soils and upland plants were also verified within and south of the resource. The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page

41217), states "For clarification, it should be noted that we generally do not consider the following waters to be Waters of the United States.... (a) non-tidal drainage and irrigation ditches excavated on dry land."

Based on a review of information submitted by SEC Inc. as well as aerial photography, a USGS quadrangle map, soil samples, a review of the National Hydrologic Dataset, U.S. Fish and Wildlife National Wetland Inventory database, wetland data sheets from Eastern Mountain and Piedmont Regional Supplement to the 1987 Wetland Delineation Manual (Version 2.0), photographs of the project site, and a site inspection of the survey area on July 14, 2022 I have determined WWC-2 is not a water of the U.S. and is not jurisdictional under Section 404 of the Clean Water Act as defined by 33 CFR Part 328.3(a).

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
